BEFORE YOUR JOURNEY

The Christian Radich Foundation follows all guidelines and regulations given by the Norwegian Institute of Public Health and the Norwegian Maritime Authority for our sailings. We will continuously monitor the infection situation and the general infection measures in society and adapt accordingly. We must comply with the national and local regulations for the ports we visit. As long as other countries continue to have entry limits, testing and quarantine requirements have to be observed and documented.

To uphold the safety of our co-sailors and crew in relation to Covid-19, we are currently following extraordinary measures:

Anyone who plans to sail with Christian Radich must complete a health declaration form and bring it on board. The form can be found with your booking, on "My Page". If you are uncertain in relation to any of the questions on the form, please contact us before departure. The form is sent out well in advance of departure along with final updates. You can also find it on "My page" with your booking.

If you have symptoms of Covid-19, even mild symptoms, you should not travel with us unless you can provide a negative test taken no later than 48 hours before departure.

CHECK-IN ON THE QUAY BEFORE BOARDING

Check-in will start 3 hours before departure. Co-sailors will meet in cohorts of 4 for check in to avoid large groups. We will send you an e-mail approx. 14 days before departure informing you of when to meet at the quay. We will test all co-sailors before boarding. We use the Panbio Covid-19 AG Rapid Test Device, which is taken about 2 cm into each nostril, thus simplifying sampling.

Keeping your distance to people other than your own travel companions is of utmost importance. We encourage everyone to use a face mask while waiting for the test and until they have shown a negative result and gone on board. When the test is taken, everyone must use a face mask.

Have your boarding card / ticket ready and deliver the self-declaration form to our crew.

Our medic will carry out the test (in a partially enclosed tent) while your co-sailors wait in the adjoining area. The test result is available after 15 minutes.

With a NEGATIVE test result

- The co-sailor is invited on board and can remove their face mask on the walkway.

With a POSITIVE test result

- The co-sailor and travel companions cannot join the trip and must leave the area.
- The payment for the Sea Norway trip with Christian Radich is refunded.
- PCR test must be carried out in the local district. Christian Radich will notify the municipality in compliance with infection tracking regulations.

With an INVALID test result

- The test must be retaken

HYGIENE ON BOARD

Routines for hand washing and hygiene will be explained during the introduction for new co-sailors. Information about the hygiene routines is displayed in central points on board. Disinfectant will be available many places on board. Frequent hand washing is very important.

Visitors will not have access to the ship and we will therefore not organise "open ship" events at the ports. Planned excursions can be implemented on condition that the current infection control advice and rules are followed.

IN CASE OF INFECTION ON BOARD

If a situation should occur in which a person on board exhibits symptoms, he or she will immediately be isolated in their own cabin and tested. We will also follow the rules for handling proven infection on board.

We have sufficient stocks of all the necessary infection protection equipment on board. We have a medic on board. We have official passenger lists for everybody on board, so that infection tracking can be efficiently implemented.

We also encourage everyone to show consideration to their co-sailors and follow the Norwegian Institute of Public Health's infection control rules.
